- iv) Matric Certificate (showing date of birth) issued by Secretary, BISE (*Result Card not acceptable*).
- v) Intermediate Certificate issued by Secretary, BISE (*Result Card not acceptable*).
- vi) **2nd Class or Grade "C" B.E in Electrical/Mechanical/Electronics or equivalent qualification** recognized by HEC and above degree (if any).
- vii) Result Cards/Transcripts/DMCs etc. of **B.E in Electrical/Mechanical/Electronics or equivalent qualification** showing CGPA/Grade/ Division and exact date of declaration of results
- viii) Certificate of Registration with **PEC** as proof of date of **initial** registration and Registration Card as proof of **Valid** registration for Engineering degree holders.
- ix) Self Domicile Certificate (**SDC**) of GB.
- x) In case of Govt. Servant, Departmental Permission Certificate (**DPC**) (Original) with exact date of appointment and domicile accepted on FPSC's prescribed Form (available on FPSC's website) duly signed and stamped by issuing authority.
- xi) Equivalence Certificate from **HEC/PEC** in case of possessing Foreign Degree or a Degree other than the advertised one.
- xii) Experience certificates, if any.

2. As per procedure/practice in vogue, **only Fifteen (15)** top merit eligible candidates in their respective Provincial/Regional quotas will be shortlisted for interview. They are cautioned that requisitioning of the documents for determination of their eligibility shall not vest any right in them for the posts until they are shortlisted on the basis of merit and relevant Provincial / Regional quota. In case, any of the candidates failed to submit these documents within stipulated period, their candidature for the captioned posts shall stand rejected and no alibi or excuse shall be entertained subsequently.
