



**RECRUITMENT IN SINDH POLICE (FOR LEGAL HEIRS OF SHAHEED, DECEASED, AND PERMANENTLY INVALIDATED OR INCAPACITATED EMPLOYEES OF SINDH POLICE)**

Applications are invited from the legal heirs of Shaheed, Deceased and Permanently Invalidated or Incapacitated Police Employees having domicile of Sindh Province for recruitment in the following posts reserved in the ranges/units on the basis of aforementioned quota:-



**IMPORTANT NOTE:**

1. Application processing fee of Rs.290/- (non-refundable) for physical part is required to be deposited in PTS account. However, RS.50/- will be deposited separately. Application form along with deposit slip can be downloaded from PTS Website [www.pts.org.pk](http://www.pts.org.pk).
2. Application should be accompanied with documents i.e copies of attested documents i.e CNIC of applicant & Shaheed, Deceased, and Permanently Invalidated or Incapacitated Employees, Domicile, PRC Educational Certificates of applicant, Death Certificate of Shaheed & Deceased, Order for Permanently Invalidated or Incapacitated Employees, Declaration of Shaheed, FIR, Obituary, Heirship Certificate, Financial Compensation order, Affidavit of Spouse / widow or mother of Shaheed / Deceased and 04 recent Passport Size Photographs. All candidates should sign a declaration that all information provided by him is correct.
3. All applicant's claims shall be considered, processed and entertained as per Recruitment Rules-2021 notified for recruitment against Shaheed, Deceased, and Permanently Invalidated or Incapacitated Quota.
4. Those candidates who qualify physical examination/endurance tests shall be called for written test and those who qualify written test will be called for Interview.
5. Police Employees (already availed one claim by appointing themselves in Sindh Police against shaheed quota) are advised to submit application forms if they are entitled for second claim for appointment to the post of ASI as per cut-off date i.e after 11<sup>th</sup> June 2014.
6. Candidates must bring their original documents at the time of Interview.
7. Applicant's age shall be calculated as per cut-off date i.e 13.04.2019 as one time waiver to legal heirs of Shaheed Employees of Sindh Police and in respect of legal heirs of Deceased Employees of Sindh Police age shall be calculated w.e.f.03.09.2019 as one time waiver.
8. All those legal heirs who appeared in different tests before notifying Sindh Police (Shaheed, Deceased, and Permanently Invalidated or Incapacitated Quota) Recruitment Rules 2021 i.e 23.08.2021 stands cancelled and they all will have to apply afresh for the post of ASI if they are willing and entitled as per aforementioned Rules.
9. Quota against Shaheed, Deceased and Permanently Invalidated/Incapacitated for the post of Junior Clerk has already been filled in Sindh Police as per available sanctioned post. However, candidates may apply for the post of ASI if they fulfill eligibility criteria and are entitled as per aforementioned Rules 2021.
10. The reserved quota shall first be utilized to exhaust the claims for recruitment of legal heirs of Shaheed Police employees as per Recruitment Rules 2021.
11. The actual verification of original certificates will only be done in respect of candidates who are called for "Interview" and any applicant having made an incorrect/false declaration shall stand disqualified automatically at any stage.
12. Incomplete application shall not be entertained.
13. Candidates qualified in physical/endurance test shall only be called for written test by PTS. Test venue and date shall be communicated separately.
14. Date, time & venue of all tests shall also be intimated through letters, SMS and PTS Website [www.pts.org.pk](http://www.pts.org.pk).
15. No TA/DA will be given for test/interview.
16. No relaxation in upper age limit is allowed.
17. Candidates who do not fulfill the given criteria are advised not to submit application forms.
18. Last date of submission of application forms is **22.09.2022**. Application forms received after expiry of last date will not be entertained.
